RULES AND REGULATIONS FOR THE COLLEGE STUDENTS: A.Y.: 202 - 2

- 1. <u>Attendance & Examination eligibility</u>: Minimum 75% attendance is compulsory required separately in each theory as well as practical according to Gujarat University Ordinance (O.B.Sc.-12) & Gujarat Govt. (NEP-2020, SOP Article 7.3) Otherwise the examination of the respective subject cannot be taken.
- 2. <u>Practical & Assignment</u>: Students will be entered in the laboratory if they bring their journal, record book and required equipment for practical work and as per the instructions of respective faculty. **Journal & assignments** must be verified and signed regularly with the respective faculty every week.
- **3.** <u>College's Campus Entry:</u> The Students must possess a **valid College ID Card** while on campus. Otherwise will be immediate expulsion from the college campus even if he/she is of college student.
- 4. It is necessary to wear **Helme**t to enter in the campus with two wheelers and they must be parked their two wheelers in **designated parking** spaces, as directed by the watchman. Students are also prohibited from sitting on parked vehicles.
- **5.** Consumption or possession of **Tobacco**, **tobacco products**, **alcohol and drugs are strictly prohibited** in the college campus and if found from the student, police action will be taken against him/her.
- **6.** Any writing, stickers or posters are prohibited on the walls of the College building, compound wall or anywhere in the premises. **Damage to the property of the institute must be avoided** otherwise strict action will be taken and the charges for the damages will be recovered by the college authorities from the student found responsible for the act.
- 7. Students are expected to refrain from **making derogatory comments or engaging in offensive behaviour** towards fellow students, professors, administrative, laboratory and any campus's working staff. Politeness and respect are mandatory with campus's any respective working staffs; otherwise, the Discipline Committee may impose appropriate disciplinary actions. Students must also maintain proper decorum during all college's functions and programs
- **8.** The use of **mobile phones is strictly forbidden** during classroom and laboratory sessions, library. Any mobile phone found in use may be confiscated/seized by faculty members, and legal action may be taken against him/her.
- **9.** Strict action taken against any uncultured, undisciplined, affray and troublesomeness behavior or breach of peace towards any faculty or students in the classroom or any laboratory during academic works.
- 10. As per timetable, the student must attend the lectures at allotted classroom don't be seated in other classroom. As well keep in mind that vacant class-rooms must be used for educational (reading and/or writing) purposes only.
- 11. Silence must be maintained when classes are going on in class-rooms and Laboratories. Students must not roam in lobbies or campus except recess time. Additionally, playing games or engaging in any **disruptive activities is prohibited** during College's working hours from 12:00pm to 5:00pm.
- 12. Library may be used only during the Recess time and free classes, subject to adherence to library rules.
- **13.** For environment friendly campus, it is our duty to keep cleanliness, use dustbins to throw garbage, as well switch off fans and lights when not in used.
- **14.** If any student is having a problem, he/she must first contact the concerned Professor as well In-charge Professor, and if the issue is not resolved, and no solution has been found, the individual should contact the Principal. However, they should not approach the Principal directly.
